GOAL LINE is a (PGPR) PLANT GROWTH PROMOTING RHIZOBACTERIA. GOAL LINE contains potassium, micro nutrients, and organic acids that are proportioned and metabolized in a way as to promote the plant to fruit, produce seed and enhance cell elongation. GOAL LINE is compatible with most fungicides. In all cases, it is recommended that a jar test be made to determine compatibility.

RECOMMENDED APPLICATION

Apply Valley Goal Line at 3-7gallons per acre. Contact a local Valley Agronomics LLC representative for more instructions. Goal Line is compatible with most sprinkler and drip irrigation. Always agitate before use to get any sediment back into solution. It is recommended to flush the system after each application to prevent possible sediment clogging.

HANDLING AND STORAGE

Follow appropriate safety procedures. Skin contact may cause irritation, reddening, and temporary staining. Use gloves, goggles, and all normal precautionary measures. In case of accidental exposure, flush with plenty of water. Product is non-hazardous. SHAKE/AGITATE WELL BEFORE USING. Storage in a cone-bottomed tank to facilitate agitation is recommended. Agitation prior to production transfer and application is required. Storage for longer than 12 months is not recommended.
